DURING FY 2014 CATHERINE'S HOUSE PROVIDED CARE TO 60 ADULT WOMEN AND 41 CHILDREN. THERE WERE 4,033 NIGHTS OF CARE PROVIDED TO ADULT WOMEN DURING THE YEAR. THIS RESULTED IN A FACILITY OCCUPANCY RATE OF APPROXIMATELY 79% FOR ADULT WOMEN BASED ON 14 AVAILABLE BEDROOMS. FOR CHILDREN THERE WERE 2,267 NIGHTS OF CARE PROVIDED WHICH RESULTED IN AN OCCUPANCY LEVEL OF 62% BASED ON 10 BEDS AVAILABLE FOR CHILDREN.
