THERE WERE 3,944 NIGHTS OF CARE PROVIDED TO ADULT WOMEN DURING THE YEAR (MAXIMUM CAPACITY IS 5,124 NIGHTS). THIS RESULTED IN A FACILITY OCCUPANCY RATE OF APPROXIMATELY 77% FOR ADULT WOMEN BASED ON 14 AVAILABLE BEDS. FOR CHILDREN THERE WERE 2,349 NIGHTS OF CARE PROVIDED (MAXIMUM CAPACITY IS 3,660), WHICH RESULTED IN AN OCCUPANCY LEVEL OF 64% BASED ON 10 BEDS AVAILABLE FOR CHILDREN.
