DURING FY 22, CATHERINE'S HOUSE PROVIDED CARE TO 54 ADULT WOMEN AND 36 CHILDREN FOR A TOTAL OF 90 INDIVIDUALS. THERE WERE 4122 NIGHTS OF CARE PROVIDED TO ADULT WOMEN DURING THE YEAR (MAXIMUM CAPACITY IS 5,110 NIGHTS). THIS RESULTED IN FACILITY OCCUPANCY RATE OF APPROXIMATELY 81% FOR ADULT WOMEN BASED ON 14 AVAILABLE BEDS. FOR CHILDREN THERE WERE 2407 NIGHTS OF CARE PROVIDED (MAXIMUM CAPACITY IS 3,650) WHICH RESULTED IN OCCUPANCY LEVEL OF 66% BASED ON 10 BEDS AVAILABLE FOR CHILDREN.
